ORDINANCE NO. 1161 - AN ORDINANCE OF THE COMMISSIONERS OF CAMBRIDGE, MARYLAND AMENDING § 6.5.3 OF THE CITY'S UNIFIED DEVELOPMENT CODE TO PERMIT STRINGS OF LIGHT BULBS FOR OUTDOOR DINING AT A RESTAURANT OR CAFE OR IN A RESIDENTIAL YARD AT OR BEHIND THE LINE OF THE PRIMARY REAR BUILDING FACADE, SUBJECT TO
