7. Appointment of Thomas M. Carroll – Cambridge City Manager

The Acting City Manager gave an overview of the new City Manager and has asked Council to appoint Mr. Thomas M. Carroll. On a motion by Commissioner Harrington and seconded by Commissioner Roche, Mr. Carroll was then appointed as City Manager. Mr. Carroll's start date will be April 20, 2022.

8. Request For Proposals (RFP): RFP Pine Street Historic District Small Area Plan (PSNSAP) Consultant.

Pat Escher explained to Council the process and need for the RFP. Ms. Escher stated that the next step was to direct staff to move forward with the RFP. On a motion by Commissioner Spuddy Cephias and seconded by Commissioner Harrington the RFP was approved on a 5-0 vote.

9. Economic Development and Grants Positions

Acting City Manager explained the need to fill these positions, stating that a lot of time would be spent working on grants. Commissioner Malkus feels the grant administrator position would be great for the community. Commission President Lajan Cephias stated that the grant administrator position would be an asset for the City. On a motion by Commissioner Spuddy Cephias and seconded by Commissioner Malkus, the creation of a grants administrator position was approved along with filling the Economic Development position was approved. The motion passed unanimously.

10. City Lobbyist – The Acting City Manager gave an overview of the City Lobbyist proposal. He explained that there are funds in the FY22 budget for this position. On a motion by Commissioner Spuddy Cephias and seconded by Commissioner Malkus this request was approved on a 5-0 vote.

11. CDBG Grant Public Hearing –

RESOLUTION NO. 22-01 - A RESOLUTION OF THE COMMISSIONERS OF CAMBRIDGE, MARYLAND TO APPROVE THE APPLICATION(S) FOR AND RECEIPT OF COMMUNITY DEVELOPMENT BLOCK GRANT (“CDBG”) FUNDING FOR FISCAL YEAR 2022 - PINE STREET NEIGHBORHOOD SPECIAL PROJECT (THE “PROJECT”) IN THE AMOUNT OF \$2,800,000.00, WITH SUCH FUNDING TO BE PROVIDED BY THE STATE OF MARYLAND DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT (“DHCD”).

Commissioner Spuddy Cephias motioned to go into public hearing.

Yvette Robinson gave an overview of the CDBG grant. The CDBG grant is requesting 2.8 million dollars for homeowner rehabilitation. It involves upgrades to Cornish Park, Bethel and Wells Street. The CDBG grant will also provide programs to assist the community in

homeownership. There will also be new construction on Chesapeake Court and Schoolhouse Lane. The CDBG grant will also support infrastructure.

Ms. Robinson also explained the HOW program. The Governor has allocated ten million dollars, with Baltimore and Cambridge having been chosen as the only cities to participate.

Commission President Lajan open the floor for public comment CDBG public hearing.

Public Comment – CDBG Public Hearing

LaShon Foster asked if this grant is the same as the old grant for improvement to the Pine Street area. Ms. Robinson explained the process of the monies involved in the grant. She also stated that we would be giving new contractors an opportunity to work with the City.

Mike Detmer stated that the areas mentioned in the CDBG grant are areas that need additional help.

A motion to close the public hearing by Commissioner Sputty Cephas and seconded by Commissioner Malkus, on a vote of 5-0 this was approved.

Commissioner Harrington stated that he was excited that the City was getting funding from the state. He also thanked Ms. Robinson for her help.

Commissioner Roche also thanked Ms. Robinson, Pat Escher and state for their help. He also stated his concern about the park being fenced in.

Commissioner Sputty Cephas thanked Ms. Robinson and Pat Escher for their efforts in making this all happen. He also stated that he is excited that our City was chosen for the HOW program.

A motion to adopt Resolution 22-01 was made by Commissioner Harrington and seconded by Commissioner Sputty Cephas and approved on a 5-0 vote.

Chief Lewis stated that the Police Department received a \$8,000 donation for the lighting on Woods Street. The Chief also said that the annual Easter Egg Hunt will be April 16, 2022, from 1pm-2pm at Long Wharf.

Pat Escher spoke regarding getting a grant from the DNR which will go to the Cannery Park. Ms. Escher also spoke on the final plans for the Leonard Lane project.
