

The City Commission held its regularly scheduled meeting on Monday, April 11, 2022. The meeting was scheduled for its regular time of 6:00 p.m. in the City Commission Chambers at 305 Gay Street in Cambridge. The Commission President Lajan Cephas opened the meeting at 6:00 p.m. Those present in person or virtually were Commissioner Brian Roche, Commissioner Jameson Harrington, Commissioner Sputty Cephas, Commissioner Chad Malkus, City Assistant Attorney Patrick Thomas, City Police Chief Mark Lewis, and Acting City Manager David Deutsch. 6. **ORDINANCE NO. 1192 - AN ORDINANCE OF THE COMMISSIONERS OF CAMBRIDGE, MARYLAND AMENDING §§ 6.3.2, TABLE 6A (SCHEDULE OF MINIMUM OFF-STREET PARKING REQUIREMENTS BY LAND USE) AND 6.3.3 (MODIFICATION OF PARKING REQUIREMENT) OF THE CITY'S UNIFIED DEVELOPMENT CODE FOR THE PURPOSE OF PROVIDING FOR MAXIMUM OFF-STREET PARKING REQUIREMENTS FOR NEW DEVELOPMENT BY LAND USE; PROVIDING THAT THE TITLE OF THIS ORDINANCE SHALL BE DEEMED A FAIR SUMMARY AND GENERALLY RELATING TO OFF-STREET PARKING IN THE CITY OF CAMBRIDGE.**

On a motion by Commissioner Sputty Cephias and a second by Commissioner Malkus the Public Hearing was opened. The City Attorney read the Ordinance aloud. On a motion by Commissioner Roche and a second by Commissioner Malkus, Ordinance 1192 was approved as presented. On a motion by Commissioner Sputty Cephias and a second by Commissioner Malkus the Public Hearing was closed.

Old Business

7. Refuse Collection

The Acting City Manager is requesting to extend the refuse contract for six months. Commissioner Malkus stated that the capital cost for City operation needs to be considered. Commission President Lajan Cephias would like to bring the service back in-house. Commissioner Roche stated that recycling could be an added service, and that accountability is necessary. A motion by Commissioner Sputty Cephias and seconded by Commission President Lajan Cephias to direct the City Manager, staff to gather information to prepare for an RFP regarding the service, and to analyze the cost of in-house service. The motion contained a 45-day period for staff to conduct the assessment, and report back to Council. The motion passed unanimously.

New Business**8. Police Accountability Software**

On a motion by Commissioner Spuddy Cephas and a second by Commissioner Malkus and a 5-0 vote the request for accountability software was approved.

Robert Aaron – spoke regarding having a skateboard park in Cambridge, suggesting that the skate park in Salisbury could be an good model.

Adrian Holmes – spoke regarding the easement for Cannery Way. Pat Escher directed her to have the easement drafted.

Department/Division Head Reports

Chief Lewis – spoke regarding the new accountability software and how it could be paid for with Forfeiture Fund monies initially and provided for in future years budget.

Pat Escher - gave an update on the Maces Lane project. Ms. Escher stated that a member of the Maces Lane community group will be acting as project manager.

Acting City Manager Comments

David Deutsch – stated that the street sweeper schedule has been posted on the website. He stated that election RFP responses are due on May 6th. He then gave a brief overview of the Bradford House, the various actions taken by staff regarding the resident complaints.

Commissioners' Comments

Commissioner Roche spoke of the pedestrian markers that have gone up around town, along with the 4-way stops. Commissioner Roche also spoke of the need for improvements on Poplar Street.

Commissioner Harrington stated that he attended the Tuskegee Airman Event held at Sailwinds over the weekend.

Commissioner Spuddy Cephias thanked the Acting City Manager for his time.

Commissioner Malkus spoke regarding the hiring of an Executive Director for Main Street, he then thanked the Acting City Manager for his time here in the City.

Commission President Lajan Cephias spoke regarding our community uniting and helping each other. She then thanked the Acting City Manager.

A motion to adjourn was made by Commissioner Spuddy Cephias and a second by Commissioner Malkus.

With no further business, Commission President Lajan Cephias adjourned the meeting at 7:40p.m.
