SUBJECT: Ordinance 1134 An Ordinance of the Commissioners of Cambridge, Maryland amending § 2.4.2(e) of the City's Unified Development Code ("UDC") to provide for the replacement of existing nonconforming multi-family structures within the Residential District that are damaged or destroyed by accidental or natural causes under certain conditions; and amending § 2.4.2(f) of the UDC regarding the timeframes for abandonment and discontinuance of nonconforming uses of structures and situations; providing that the title of this Ordinance shall be deemed a fair summary and generally relating to nonconforming lots, structures, and uses in the City of Cambridge.

Recommendation: That Council:

- A. Introduce Ordinance No. 1134 by reading of title only; and
- B. Schedule October 22, 2018 for second reading, public hearing and adoption of Ordinance No. 1134.

6. SUBJECT: Ordinance 1135 An Ordinance of the Commissioners of Cambridge, Maryland amending § 5.1.4 of the city's Unified Development Code ("UDC") to provide that: 1) fences shall not extend at a height exceeding six feet forward of the primary rear building façade; 2) fences extending forward of the primary rear building façade shall not exceed four feet in height subject to certain conditions; and 3) fences that have a side with exposed framing or similar features shall orient that side internal to the site; providing that the title of this Ordinance shall be deemed a fair summary and generally relating to fences in the City of Cambridge.

SUBJECT: Ordinance 1137 An Ordinance of the Commissioners of Cambridge, Maryland amending the Official Zoning Map of the City of Cambridge by rezoning three parcels of real property from Neighborhood Conservation 3 to Neighborhood Conservation 3 Overlay, as follows: 1) 111 Mill Street, Tax Identification No. 07-172672, depicted on Tax Map 301 as Parcel 122 and consisting of 42,551 square feet, more or less; 2) 115 Mill Street, Tax Identification No. 07-172699, depicted on Tax Map 301 as Parcel 123 and consisting of 54,972 square feet, more or less; and 3) 201 Mill Street, Tax Identification No. 07-173814, identified on Tax Map 301 as Parcel 124 and consisting of 1.86 acres, more or less; providing that the title of this Ordinance shall be deemed to be a fair summary, and generally relating to the Official Zoning Map of the City of Cambridge.

Recommendation: That Council:
 - A. Give Ordinance No. 1133 a second reading by reading of title only;
 - B. Open the public hearing, take public comment and close the public hearing; and
 - C. Pass Ordinance No. 1133.

Commissioner Hanson asked George Hyde to have Oden Wheeler talk to the Chesapeake Waste management about the noise the trash collectors are making before 5:00 am. It is mostly noise from them putting the cans back on the ground.

Commissioner Hanson talked about the number of times the drawbridge is opened for boaters who could put their antennas down instead of requesting a bridge opening. Traffic is backing up for blocks.

Chief Adam Pritchett reported about the Fire Prevention Week activities.
