

The City Council met in regular session on Monday, January 27, 2020 in Council Chambers. A quorum being present, Mayor Victoria Jackson-Stanley was absent, the meeting was called to order at 6:00 pm by Commissioner Rideout, Mayor Pro-tempore. Those Commissioners in attendance were Commissioners Rideout, Sydnor, Foster, Cannon, and Hanson. Commissioner Rideout asked for a moment of silence then Commissioner Hanson led in the Pledge of Allegiance.

1. A motion to approve the Agenda was made by Commissioner Hanson and seconded by Commissioner Cannon. The motion passed 5-0.

### **Ordinances for Second Reading, Public Hearing, and Adoption**

6. ORDINANCE NO. 1161 - AN ORDINANCE OF THE COMMISSIONERS OF CAMBRIDGE, MARYLAND AMENDING § 6.5.3 OF THE CITY'S UNIFIED DEVELOPMENT CODE TO PERMIT STRINGS OF LIGHT BULBS FOR OUTDOOR DINING AT A RESTAURANT OR CAFE OR IN A RESIDENTIAL

YARD AT OR BEHIND THE LINE OF THE PRIMARY REAR BUILDING FACADE, SUBJECT TO CERTAIN CONDITIONS, AND TO CLARIFY THAT SEASONAL EXTERIOR LIGHTING IS PERMITTED; PROVIDING THAT THE TITLE OF THIS ORDINANCE SHALL BE DEEMED A FAIR SUMMARY AND GENERALLY RELATING TO EXTERIOR LIGHTING IN THE CITY OF CAMBRIDGE.

The city attorney read the ordinance aloud. A period of public comment was offered to anyone present. No citizen present chose to speak during public comment. Commissioner Hanson made a motion to approve the ordinance. Commissioner Canon seconded the motion. The motion passed on a 5-0 vote.

### Old Business

7. Commissioner Sydnor made a motion to allocate \$77.78 to the CPD Event Fund. The motion was seconded by Commissioner Hanson. The motion passed on a 5-0 vote.
8. Mayor Pro-tempore Rideout read off the five names recommended by city commissioners for the Elected Official Compensation Advisory Committee appointments:

A motion was made by Commissioner Hanson and Seconded by Commissioner Canon to approve the appointments. The motion passed 5-0.

### New Business

9. Commissioner Hanson made a motion to appoint George Breig to the City Planning Commission. The motion was seconded by Commissioner Cannon and adopted with a 5-0 vote.
10. Commissioner Hanson made a motion to declare the old city SWAT vehicle, VIN# IFDKF37F6SNA81123, 1995 Ford ambulance, as surplus property so the vehicle could be auctioned off. The motion was seconded by Commissioner Cannon. The motion passed on a 5-0 vote.

Commissioner Foster and the Police Chief requested on behalf of the Traffic and Safety Committee to install streetlights at 707 Stiles Circle and at Greenway and Maryland Avenue. A motion of approval was made by Commissioner Hanson and seconded by Commissioner Cannon. The motion was approved on a vote of 5-0.


