

The City of Cambridge - Council Meeting Minutes August 8, 2022

The City Commission held its regularly scheduled meeting on Monday, August 8, 2022, at 6 p.m. The meeting was located at the City Council Chambers at 305 Gay Street in Cambridge, Maryland. The Commission President Lajan Cephas opened the meeting at 6:00 p.m. Those present in person or virtually were Commission President Lajan Cephas, Commissioner Brian Roche, Commissioner Jameson Harrington, Commissioner Sputty Cephas, Commissioner Chad Malkus, City Attorney Patrick Thomas, Police Chief Mark Lewis, Fire Chief Adam Pritchett, and City Manager Thomas Carroll. ORDINANCE NO. 1197 — AN ORDINANCE OF THE COMMISSIONERS OF CAMBRIDGE, MARYLAND AMENDING § 4.5 OF THE UNIFIED DEVELOPMENT CODE FOR THE PURPOSE OF REQUIRING THAT CONTRACTS FOR THE SALE OF REAL PROPERTY WITHIN THE CAMBRIDGE HISTORIC AREA OVERLAY DISTRICT INCLUDE A STATEMENT OF THAT FACT; REQUIRING SELLERS OF SUCH PROPERTY TO PROVIDE BUYERS WITH CERTAIN INFORMATION; AND GENERALLY RELATING TO REAL PROPERTY WITHIN THE CAMBRIDGE HISTORIC AREA OVERLAY DISTRICT.

ORDINANCE NO. 1202 — AN ORDINANCE OF THE COMMISSIONERS OF CAMBRIDGE, MARYLAND AMENDING § 9.2 AND TABLE 1: PERMITTED USES BY ZONING DISTRICT OF THE CITY'S UNIFIED DEVELOPMENT CODE FOR THE PURPOSES OF PROVIDING THAT DRY CLEANING PLANTS SHALL BE A PERMITTED USE IN THE INDSUTRIAL ZONING DISTRICT AND DEFINING DRY CLEANING PLANTS; PROVIDING THAT THE TITLE OF THIS ORDINANCE SHALL BE DEEMED A FAIR SUMMARY AND GENERALLY RELATING TO DRY CLEANING PLANTS IN THE CITY OF CAMBRIDGE

City Manager Thomas Carroll spoke that about 20 applicants for the positions with the CWDI Board. He noted that the skills would need to be in the area of economic development, marketing, law, real estate, etc.

Motion by Commissioner Roche to have Council President Cephas and Commissioner Malkus with Tom Carroll to be on the CWDI Review Committee. They will review the applications and report back to the City Council with the top 5 applicants. The motion was seconded by Commissioner Harrington. Approved 5:0

15. Discussion of Fire Rescue Truck Purchase and Presentation by the Rescue Fire Company

Mr. Adam Pritchett gave a presentation of the Rescue Fire Departments equipment, which includes one ladder truck, one rescue truck, four engine trucks and one hazmat truck and other various rescue and safety equipment. He compared our city to others with the same size and population. He made the presentation for the Council and citizens to understand the age of the equipment and how the future purchase of a rescue truck will benefit the city

for the next 25 to 30 years, by increasing the size to accommodate all the equipment needed for a rescue and the age of the truck. Rescue Fire Dept receives some funding from the Dorchester County and from the State of Maryland 508 Funds. After more discussion, the Council decided to have the Rescue Fire Dept. to continue to repair their trucks.

Motion from Commissioner Harrington to proceed with the purchase of a new rescue truck as the budget allows. The motion was seconded by Commissioner Malkus. Approved 5:0

Mrs. LaShawn Foster (Southside Dr., Cambridge) wanted to thank the Council and the Rescue Fire Dept. for their hard work in making their decision tonight. She hopes that the Council spreads the budget to every ward of the city.

Ms. Adrian Holmes (Maryland Ave., Cambridge) wanted to thank the Rescue Fire Dept. for their presentation and the information giving to this Council to approve the purchase. She also gave an update of the Day of Resilience with the Ambassadors and number of buses planned to come to the three-day event.

Dr. Theresa Stafford (Rock Dr., Cambridge) congratulated the Council and the Rescue Fire Dept. for the approval of the new purchase of a truck. She also stressed that she attended the West End Committee's recent meeting at Gerry Boyle Park about the need for more police presence in that area. She mentioned that she has for many years stressed the need for more police presence in the areas of Greenwood Ave and Ward 2.

Ms. Mya Woods (Governors Ave., Cambridge) also congratulated the Council and the Rescue Fire Dept. for the purchase. She also wanted to thank the persons who attended her recent Zoom meeting and for providing their feedback. She would like some more information on the Leonard Lane Park that has been talked about in the community.

Mr. Jermaine Anderson (Cambridge) wanted to express the need to also have Dorchester County to help with some of the funding with the Rescue Fire Dept.

Ms. J. Churchill (Teal Ln., Cambridge) also wanted to express her gratitude to moving forward with the purchase of the rescue truck and hopes this Council will work just as hard with the ARPA funds and the Capital Improvement as they move forward with other city purchases and contributions.

Chief Lewis thanks all who attended the Night Out event, which had over 700+ participants.

City Manager Comments

Mr. Tom Carroll expressed the amount of \$389,000.00 for the Leonard Lane Park from the State of Maryland and the Green Street policy that our Planning Department has in mind.

Commissioner's Comments

Ward 1 expressed a need to have Pine Street on the top of the paving list and other calm areas in the City.

Ward 2 expressed the reasons for the new Leonard Lane Park and the focus group that is working with the Planning Department to make it happen.

Ward 3 – none at this time

Ward 4 stated that more support from the residents with less complaints without solutions and to have more feedback with solutions or ideas for the Council to make their discussions more productive and accountable.

Ward 5 responded that the Rescue Fire Dept. had an informative presentation and answered a lot of their questions. He also expressed the City Cemetery was also receiving improvements in the next few months.
