

# Yacht Basin Rate Schedule

- Slips are billed by calendar year - January 1<sup>st</sup> through December 31<sup>st</sup>
- All Contracted Lessees' must make a onetime Electric Deposit of \$100. \*See Footnote
- Contractual agreements may be paid up front or in halves – The 1<sup>st</sup> half being due by January 31<sup>st</sup> & the 2<sup>nd</sup> half being due by May 31<sup>st</sup>. \*\*See Footnote
- Lessee's that have their primary residence inside City limits receive a 10% discount on their slip rental rate.
- Lessee's that reside in Dorchester County, but outside the city & has a current Tidewater Fishing License (TFL) receive a 20% discount on their slip rental rate. \*\*\*See Footnote
- Slip fees are non-inclusive of electric charges. Lessees will be billed by usage on a quarterly basis. You may place a lock on your meter; it will be the lessee's responsibility to provide the lock.

The City of Cambridge offers a discount for long-term lessees that agree to pay the fee's upfront. There is a 5% discount for a 2-year contract & a 7.5% discount for a 3-year contract. \*\*\*\*See Footnote

**WEEKLY RATE** - \$6.00 \*FT + (\$25 for 30amp service / \$50 for 50amp service)

**DAILY RATE** - \$2.00 \* FT

**CRUISE SHIPS** - \$2.00 \* FT (per day)

**WATERMAN'S RATE** – Electric will be billed at the prevailing rate & **either** of the following:

- 1/6<sup>TH</sup> of annual rate (by slip length) minus 20% discount
- \$600 annually if located in Waterman's Row.

**LATE FEES** – See Rules & Regulation's

**FOOTNOTES:**

\* Refund ability of Electric deposit is contingent upon up-to date account billings at time of cancellation or non-renewal of your slip.

\*\*Contracts made randomly throughout the year & not at the beginning of the billing season, will be billed on a Pro-rated basis with fee's being due by date on invoice.

\*\*\*City Residents also holding a (TFL) can only receive the higher discount of the two (20%); not both.

\*\*\*\*Slip fees are non-refundable
